## FACTS

### WHAT DOES DIVIDEND SOLAR FINANCE LLC DO WITH YOUR PERSONAL INFORMATION?

#### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Credit history and credit scores
- Checking account information and employment information

When you are *no longer* our customer, we continue to share your information as described in this notice.

#### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information, the reasons Dividend Solar Finance chooses to share and whether you can limit this sharing.

What we do	
How does Dividend Solar Finance protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Dividend Solar Finance collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> <li>■ Open an account or give us your income information</li> <li>■ Provide employment information or apply for financing</li> <li>■ Show your driver’s license</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates or other companies.</p>

<p><b>Why can't I limit all sharing?</b></p>	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> <li>■ Sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>■ Affiliates from using your information to market to you</li> <li>■ Sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>

Definitions	
<p><b>Affiliates</b></p>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p>
	<ul style="list-style-type: none"> <li>■ <i>Our affiliates include Dividend Finance Inc., Figtree Company, Inc., Dividend Solar, Inc., Dividend Solar Finance LLC, Dividend Solar LLC, DS Advisory LLC, DS Global Holdings LLC, and Figtree PACE Bond Holdings, LLC.</i></li> </ul>
<p><b>Nonaffiliates</b></p>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p>
<p><b>Joint marketing</b></p>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p>

<p><b>California Residents.</b> California law places additional limits on sharing your personal information. If you are a California resident, please see separate disclosures that will be provided to you regarding your rights under California law.</p> <p><b>Vermont Consumers/Customers.</b> If you are a resident of the State of Vermont, the information we share for joint marketing is limited to your name and contact information, and our own transaction and experience information. We will not disclose information about your credit worthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
